Training sessions are conducted for the faculty and staff to recognize and report issues of abuse and neglect.

Through its awareness campaigns and programs, the committee strives to ensure that all learners are always treated with dignity and respect. In a series of Awareness programs and Special School assemblies conducted in the school throughout the year, learner participation is encouraged.

Age-appropriate videos are shown and self-defence sessions are also conducted as a part of the Awareness programs.
