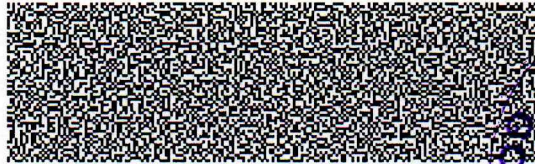

The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school and extending the cause of education in the same school only.
- That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
- That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- That the Principal and Correspondent/Manager of the School have individually gone through the provisions contained in the affiliation and examination bylaws and the circulars issued by the Board from time to time.
